Danish Data Protection Authority Has Decided to Data Processing of deCode Genetics is Accordance with the Law

As a result of the investigation carried out by the Danish DPA based on the complaint it has been determined that the personal data processing activity of data controller was not an unlawful processing.

Based on these evaluations, the Authority has decided the data processing was considered to be in accordance with the law.

French Data Protection Authority Has Decided to Impose an Administrative Fine on Clearview AI

As a result of the investigation carried out by the French DPA based on the complaint it has been determined that data controller was found responsible for violation of the European General Data Protection ("GDPR") on the grounds that the data processing activity was without a legal basis.

Regarding the very serious risks to the fundamental rights of the data subjects resulting from the processing carried out by the data controller, the Committee order Clearview AI to stop collecting and processing data of individuals residing in France without a legal basis and to delete the data of these persons that it has already collected, within a period of two months.

Based on these evaluations, the Authority has decided to impose an administrative fine of 100,000 EUR on both data controllers.

Italian Data Protection Authority Has Decided to Impose an Administrative Fine on Senseonics INC

As a result of the investigation carried out based on the inspections carried out by the Italian Data Protection Authority, it was stated that the data controller violated the European Data Protection Regulation ("GDPR") due to unlawfully disclosed e-mail accounts and health data.

It has been stated that fairness and transparency principles were also infringed since the information provided to users was unclear as well as incomplete, and the company had failed to comply with GDPR.

Based on these evaluations, the Authority has decided to impose an administrative fine of 45,000 EUR on both data controllers.

Denizli Özel Egekent Hastanesi Data Breach Notification

It has been determined that the systems of the data controller are encrypted with a ransomware attack.

It has been determined that the identity, communication, location, personnel, legal action, customer transaction, physical space security, transaction security, risk management, finance, professional experience, marketing information and visual and audio recording data of the persons affected by the violation have been obtained by unauthorized third parties.

Quick Sigorta Anonim Şirketi Data Breach Notification

It has been determined that the data controller works for the damage management system with a software program contracted from the outside and that the data in this system is captured by unauthorized third parties.

It was stated that investigations into the violation are continuing.

It has been determined that the data in the database of the data controller has been seized by unauthorized third parties with a ransomware attack.

It has been stated that the relevant person groups affected by the breach are users and subscribers/members.
