# 01

### Summary of Decision dated 06/07/2023 and numbered 2023/1154 of the Personal Data Protection Board on the Amendment of the Exception Criterion for the Obligation to Register in the Registry of Data Controllers

It has been decided unanimously by the Turkish DPA to update the annual financial balance sheet total amount expression which take place in the Board Decision dated July 19, 2018 and numbered 2018/87 “real or legal person data controllers whose annual number of employees is less than 50 and whose annual financial balance sheet total is less than 25 million Turkish Liras, whose main field of activity is not the processing of special quality personal data” as “the number of annual employees is less than 50 and the annual financial balance sheet total is less than 100 million Turkish Liras, the main field of activity is special those who do not process qualified personal data” and the decision to be published in the Official Gazette and announced on the website.

### Oden İnşaat Turizm ve Tic. A.Ş. Data Breach Notification

It has been indicated that the violation occurred on June 20, 2023 and was detected on the same day, as a result of the phishing attack on the data controller via e-mail, the booking.com Booking extranet screen is accessed by the attackers, the relevant screen contains the name, surname, reservation date, phone number, e-mail address information of the data controller’s customers, e-mail mail is sent by the attackers to the customers of the data controller from the relevant screen and credit card information is tried to be obtained, the number of relevant persons affected by the breach is 155.
