Diler Holding A.Ş. and Group Companies Data Breach Notification

It was determined that the data controller systems were infiltrated by taking advantage of the firewall vulnerability and that user accounts were seized with password attacks and ransomware was installed with the passed accounts. It was stated that the data categories of 1200 employees and users, which are identity, communication, personnel, legal process, customer transaction, physical location security, transaction security, risk management, finance, professional experience, marketing, visual and audio records were affected by the breach.

It is stated that the identity, communication, customer transaction, visual and auditory data categories of approximately 27,920 customers and potential customers were affected by the breach.
