Hotiç Ayakkabı San. ve Tic. A.Ş. Data Breach Notification

On 23.06.2023, unauthorized persons tried to log into the account defined to the data controller on the platform by receiving services regarding the permission management platform created by the data controller for sending e-mails via SMS. The company, which has the title of data processor, aimed to make a phishing attack on the data controller, and it was determined that the employees of the data controller were aware of the situation at the time of the incident by sending a text message. It was determined that 1,926,889 people and records affected by the breach were mobile phone numbers belonging to customers.

Doğan Trend Otomotiv Ticaret Hizmet ve Teknoloji Data Breach Notification

It has been determined that the breach occurred as a result of a cyber-attack on the servers of Vodatech Bilişim Proje Danışmanlık Sanayi ve Dış Ticaret AŞ (Vodatech), where the data on the storage devices became inaccessible by encrypting them. It is stated that the relevant group of persons affected by the breach, the number of records and the categories of personal data have not yet been determined.

Suzuki Motorlu Araçlar Pazarlama A.Ş. Data Breach Notification

It has been determined that the breach occurred on 31.07.2023 when the data on the storage devices became inaccessible by encrypting them as a result of a cyber attack on the servers of Vodatech Bilişim Proje Danışmanlık Sanayi ve Dış Ticaret AŞ (Vodatech). It is stated that the relevant group of persons affected by the breach, the number of records and the categories of personal data have not yet been determined.

Defacto Perakende Tic. A.Ş. Data Breach Notification

It was determined that the data breach occurred after the commissioning of the software version, which includes a series of improvements made to improve the services offered by the data processor by informing the customers that they see personal information that does not belong to them on their profile pages. It is stated that the number of people affected by the breach is 2686 and the categories of personal data affected are identity, contact and customer transaction data.

Elca Kozmetik Limited Şirketi Data Breach Notification

A data leak occurred on 30/05/2023 in the software called MOVEit, which is used globally by Estee Lauder group companies, including the data controller. It was stated that name, surname, e-mail address, mobile phone number or landline and date of birth information of the 83,185 customers and potential customers were affected by the breach.

Telcoset İleri Teknoloji Stratejik İş Geliştirme Danışmanlık A.Ş. Data Breach Notification

It has been determined that intelligence was received on 18.09.2023 that it took place as a result of a ransomware attack on data controller systems and that some information was seized by attackers within the scope of threat intelligence activity, and then it was sold or tried to be sold on the internet. It is stated that the work on the number of people affected by the breach is still ongoing, but the estimated number of people is over 1000.

Tokat Gaziosmanpaşa University Data Breach Notification

Within the scope of the threat intelligence activities carried out by the National Cyber Incident Response Center (USOM), it has been determined that student information, which is considered to belong to Reşadiye Vocational School, has been sold or tried to be sold by attackers on various forum sites on the internet. It was stated that the breach occurred on 11.09.2023, that during the investigations, the data controller systems were logged in as authorized users from the IP addresses, and that there were identity, communication, visual and audio recording data.

Johnson Controls Klima ve Servis Soğutma San. ve Tic. Ltd. Şti. Data Breach Notification

It was determined that the breach occurred as a result of the data controller being exposed to a ransomware attack. It is stated that the categories of personal data and the number of persons concerned and their groups have not yet been determined.

Havaist Taşımacılık Sanayi ve Ticaret A.Ş. Data Breach Notification

It has been determined by the data controller that the systems of the data processor from which the service is received for sending text messages have been attacked and text messages have been sent in order to gain unauthorized access to the information of the data subjects and to carry out a phishing attack. It was reported that 77,000 people's mobile phone data was affected by the breach.
